Directions: North from US Highway 6 on State Line Road (CO County Road 65/NE Road 310) approximately 2 miles to southeast corner of property at intersection of CR 26 and CR 65.

West from Venango NE, approximately ¼ mile on Colorado Highway 23 then south on State Line Road (Nebraska Road 310/Colorado CR 65) approximately 9.5 miles to north corner of property.

From Holyoke CO, drive east on US Highway 6 approximately 13 miles to State Line, then north on CR 65/Road 310 about 2 miles to south boundary of Parcel 2.
